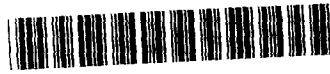

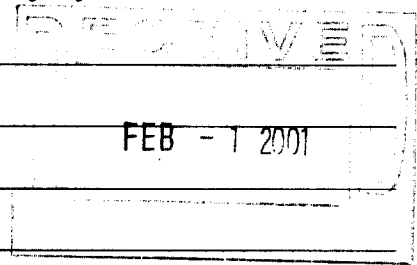

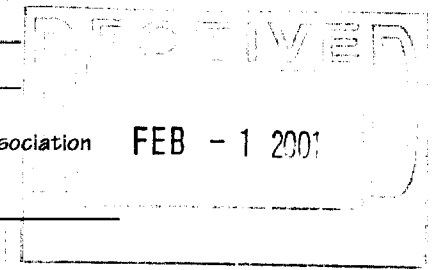

**CONFIRMATORY
ASSIGNMENT OF TRADEMARK**

WHEREAS, Aramark Entertainment, Inc. (formerly known as "Odgen Services Corporation"), a corporation organized and existing under the laws of the State of Delaware ("Assignor"), and having a principal place of business at 1101 Market Street, Philadelphia, PA 19107, is the owner of the entire right, title and interest in the trademark "Mighty Meal" and U.S. Trademark Registration No. 1,950,319 therefor (the "Mark"); and

WHEREAS, McDonald's Corporation, a corporation organized and existing under the laws and the State of Delaware and having a place of business at Kroc Drive, Oak Brook, Illinois 60521 ("Assignee"), desires to acquire all right, title and interest in the Mark, together with that portion of the goodwill of the Assignor's business associated therewith.

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN:

In order to make and record a specific formal Assignment of the Mark and the Registration therefor from ASSIGNOR to ASSIGNEE, pursuant to that certain Agreement between Assignor and Assignee dated December 15, 2000, be it known that for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by ASSIGNOR, ASSIGNOR has sold, assigned, transferred and set over, and by this instrument does hereby sell, assign, transfer and set over to ASSIGNEE, and its successors and assigns, the entire right, title and interest owned by ASSIGNOR in and to the Mark and U.S. Trademark Registration No. 1,950,319 therefor, together with that portion of the goodwill of its business associated therewith, and all claims for past damages by reason of infringement of said Mark and with the right to sue for and collect the same for ASSIGNEE's own benefit and for the benefit of its successors, assigns and other legal representatives.

And ASSIGNOR does hereby covenant and agree, for itself and its successors and assigns, that it will execute and deliver to ASSIGNEE, without expense to itself, any and all additional documents and perform any further acts necessary to vest in ASSIGNEE the rights hereby conveyed.

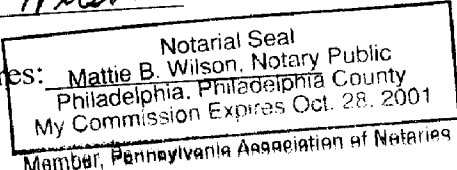
