SECURITY INTEREST IN TRADEMARKS

This Security Interest in Trademarks ("Assignment") is made as of January 31, 2001, by MediFAX®EDI, Inc., a Tennessee corporation, located at 1283 Murfreesboro Road, Nashville, Tennessee 37217 ("Debtor") and AmSouth Bank, an Alabama state bank, located at AmSouth Bank Center, Nashville, Tennessee 37237 ("Secured Party").

BACKGROUND
