

CONFIRMATORY ASSIGNMENT NLNC PRO TUNC

WHEREAS, as of October 11, 1994, CLEAR CHANNEL METROPLEX LICENSES, INC., a corporation organized and then existing under the laws of the state of Nevada, whose address was 3305 W. Spring Mountain Road, Suite 60, Las Vegas, Nevada 89102, was the owner, as the result of the merger on said date of Metroplex Communications, Inc., a Florida corporation, into said Clear Channel Metroplex Licenses, Inc., of the following mark registered in the United States Patent and Trademark Office:

WHEREAS, it was the intention of the parties that Clear Channel Metroplex Licenses, Inc. would, immediately after the aforementioned merger on October 11, 1994, transfer the aforementioned mark, as well as the registration thereof and the goodwill underlying said mark, to CLEAR CHANNEL METROPLEX, INC., a corporation which was organized and then existed under the laws of the state of Nevada, and which had an address at c/o Clear Channel Communications, 200 Concord Plaza, Suite 600, San Antonio, Texas 78216;

WHEREAS, no document was executed at that time reflecting the assignment of the subject mark;

WHEREAS, on December 31, 1998, Clear Channel Metroplex Licenses, Inc. was merged into and survived by Clear Channel Radio Licenses, Inc., a corporation organized and existing under the laws of the state of Nevada, which, on said date December 31, 1998, changed

its name to Clear Channel Broadcasting Licenses, Inc.;



THAT this Confirmatory Assignment is being executed now in order to clarify the ownership of the aforementioned registration, and to confirm that said CLEAR CHANNEL METROPLEX LICENSES, INC. did assign unto said CLEAR CHANNEL METROPLEX, INC. all right, title and interest in and to said mark, together with the goodwill associated with the mark, and the above-identified registration thereof, effective as of October 11, 1994.
