ASSIGNMENT OF TRADEMARK

This ASSIGNMENT AGREEMENT ("Agreement") is made and entered into this 31 day of July, 2000 by and between Seven Seas Communications, Inc. ("Assignor"), a Delaware corporation doing business at 1700 East Las Olas Boulevard, Suite 202, Fort Lauderdale, Florida 33301, and MarineSat Communications Network, Inc. ("Assignee"), a Delaware corporation doing business at 6650 West Inciantown Road, Suite 120, Jupiter, FL 33458.

WHEREAS, Assignor and IDB Mobile Communications, Inc. are the joint owners of the entire right, title and interest in and to the mark "OCEANCELL" and the U.S. trademark registration for the mark "OCEANCELL" and design (Reg. No. 2,091,153) (the "Mark") for use in connection with telecommunications services, namely mobile satellite communications services, including voice, fax and data transmissions;

WHEREAS, Assignor and Stratos Global Corporation, a corporation organized under the laws of Canada ("Stratos"), have entered into that certain Asset Purchase Agreement, dated June 8, 2000, as amended ("Purchase Agreement"), in which Assignor has agreed to sell and Stratos has agreed to purchase certain assets of Assignor (the "Assets"), including Assignor's right, title and interest in and to the Mark, together with the goodwill of the business associated therewith, including without limitation all license agreements, and future license royalty income;

WHEREAS, pursuant to Section 1.8 of the Purchase Agreement, Stratos, Assignee and Assignor have entered into that certain Joinder Agreement, of even date herewith, in which Stratos has agreed to assign to Assignee and Assignee has agreed to assume all rights and obligations under the Purchase Agreement, as if Assignee were the original party to the Purchase Agreement, including assignment and transfer of the Mark by Assignor.

NOW THEREFORE, for good and valuable consideration paid by Assignee to Assignor, the sufficiency and receipt of which is hereby acknowledged, each of the parties hereto, intending to be legally bound, hereby agrees as follows:

1. Assignor does hereby sell, assign, transfer and set over unto Assignee and its successors and assigns, all of Assignor's right, title and interest in and to the Mark, together with the goodwill of the business associated therewith, including without limitation, all license agreements and future royalty income; and
2. Assignee shall record this Assignment herein with the United States Patent and Trademark Office, and Assignee consents to such recordation by Assignee.

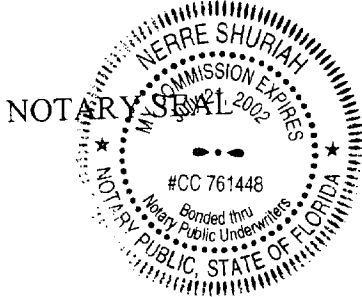
