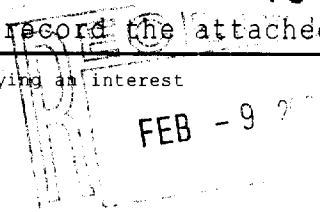


TRADEMARK ASSIGNMENT


