## CONFIRMATORY ASSIGNMENT DECLARATION

I, Steven M. Gerber, declare as follows:

1. I was an officer, i.e., secretary of Gitano Licensing Ltd., a Delaware Corporation, from about 1989 to about 1994.
2. On June 3, 1993, I executed an Assignment of Applications for United States Trademark Registrations which is recorded in the United States Patent and Trademark Office at reel 1130, frame 400 through reel 1130, frame 402 (the "Assignment") (attached as Exhibit 1).
3. Although I did not realize it at the time I executed the Assignment, I now know the Assignment contains an inadvertent error made without any deceptive intention, namely, Gitano Licensing Ltd. (New York) is erroneously listed as the Assignor and the owner of the trademarks and applications listed in the Assignment in place of Gitano Licensing Ltd. (Delaware Corporation).
4. In reality, at the time the Assignment was executed, it was the intent of the true owner of said trademarks and applications, Gitano Licensing Ltd. (Delaware Corporation), to assign all right, title and interest in said trademarks and applications as set forth in the Assignment to Americo Group, Inc.
5. I therefore confirm that Gitano Licensing Ltd. (Delaware Corporation), in consideration of the sum of one dollar (\$1.00) and other good and valuable consideration, did assign to Americo Group, Inc., as of June 3, 1993, its entire right, title and interest, including common law rights in and to said trademarks and applications which are listed in Schedule A attached to the Assignment, together with the goodwill of the business in connection with which the trademarks were used, and the right to sue for and collect damages for past infringement of the trademarks.
6. I hereby declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code, and that such willful false statements may jeopardize the validity of the registrations on which the aforesaid applications were based.
