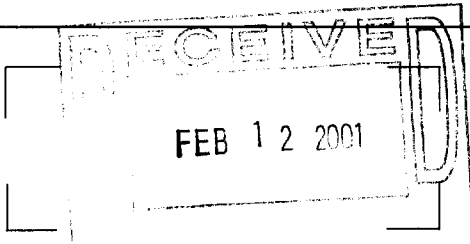

RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT

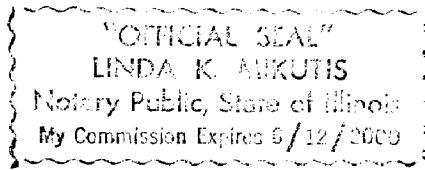
