**TERMINATION AND RELEASE OF
SECURITY INTERESTS IN
TRADEMARKS**

WHEREAS, BURNS & RICKER, INC., a Delaware corporation ("Grantor") entered into a Security Agreement recorded October 3, 1990 at the United States Patent and Trademark Office at Reel 0741, Frame 0961 (the "Security Agreement") with BBL BANK BRUSSELS LAMBERT, NEW YORK BRANCH ("BBL");


WHEREAS, Grantor granted to BBL, under the terms of the Security Agreement, a continuing security interest (the "Security Interest") in favor of BBL in and to all of Grantor's intellectual property described in the Security Agreement, including, without limitation the trademarks listed in **Schedule A** and all of the goodwill of the business connected with use of, and symbolized by trademarks owned by Grantor;


WHEREAS, Grantor granted the Security Interest to BBL in order to secure the complete and timely satisfaction of its obligations under the Security Agreement (the "Secured Obligations");

WHEREAS, all of the Secured Obligations have been completely and timely satisfied, and BBL is therefore obligated to release the Security Interest;

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, BBL hereby releases the Security Interest, hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to Grantor and its respective successors and assigns under the Security Agreement, hereby sells, assigns, transfers and sets over to Grantor and its respective successors and assigns any right, title or interest in or to the intellectual property described in the Security Agreement, including without limitation any trademarks that Grantor may have acquired, and hereby releases Grantor and its respective successors and assigns from all covenants, obligations, liabilities and warranties under the Security Agreement.
