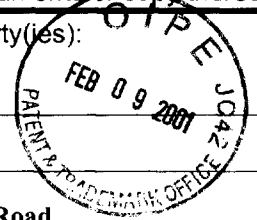

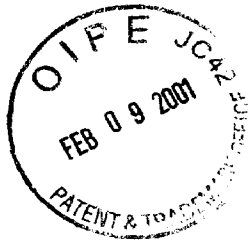

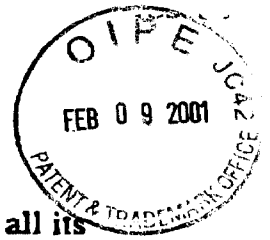
C T CORPORATION SYSTEM, a corporation organized and existing under the laws of Delaware,

DOES HEREBY CERTIFY:

FIRST: That this corporation was incorporated on the 11th day of August, 1936, pursuant to the General Corporation Law of the State of Delaware.
