

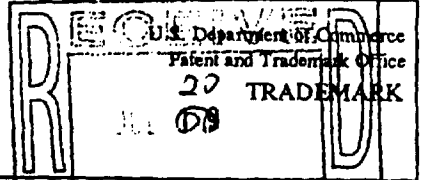

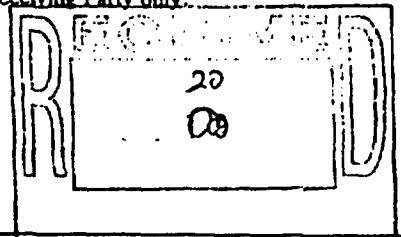


THIS AGREEMENT is dated as of January 21, 1999.
