United States Steel Corporation, a corporation organized and existing under the laws of Delaware,

DOES HEREBY CERTIFY:

FIRST: That this corporation was incorporated on the 10th day of September, 1965, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That this corporation owns all of the outstanding shares of the stock of USX Corporation, a corporation incorporated on the 23rd day of June, 1986, pursuant to the General Corporation Law of the State of Delaware.

THIRD: That this corporation, by the following resolutions of its Board of Directors, duly adopted at a meeting held on the 24th day of June, 1986, determined to and did merge into itself said USX Corporation:

RESOLVED: That United States Steel Corporation merge, and it hereby does merge, into itself USX Corporation and assumes all of its obligations.

FURTHER RESOLVED: That said merger shall become effective upon the date of filing of a Certificate of

Ownership and Merger with the Secretary of State of
the State of Delaware.

FURTHER RESOLVED: That upon effectiveness of
said merger, the name of United States Steel
Corporation shall be changed to "USX Corporation" and
Article First of the Certificate of Incorporation of
United States Steel Corporation shall be amended to
read as follows:

"FIRST: The name of the Corporation (which is
hereinafter referred to as the 'Corporation') is

USX CORPORATION"

FURTHER RESOLVED: That the proper officers of
this Corporation be, and they are hereby, directed to
make and execute a Certificate of Ownership and Merger
setting forth a copy of the resolutions to so merge
said USX Corporation and to assume its obligations,
and to so change the name of United States Steel
Corporation, and the date of adoption thereof, and to
cause the same to be filed with the Secretary of State
of the State of Delaware and a certified copy recorded
in the office of the Recorder of Deeds of Kent County
and to do all acts and things whatsoever, whether

within or without the State of Delaware, which may be necessary or proper to effect said merger and change of name.

IN WITNESS WHEREOF, said United States Steel Corporation has caused its corporate seal to be hereunto affixed and this certificate to be signed by D. M. Roderick, its Chairman of the Board of Directors, and attested by F. H. Jones, its Assistant Secretary, this 9th day of July, 1986.

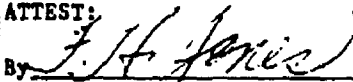

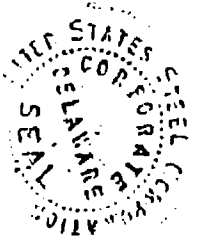

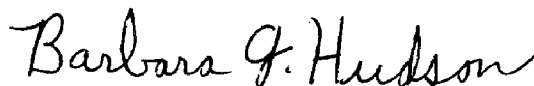
