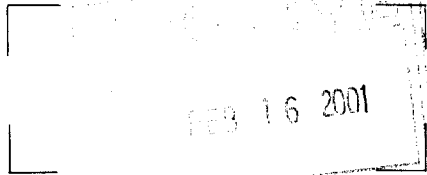



TRADEMARK ASSIGNMENT



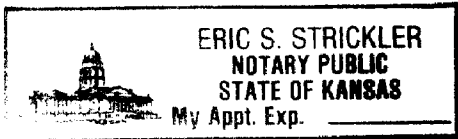
