ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION
OF
AIRSPAN COMMUNICATIONS CORPORATION

ARTICLES OF AMENDMENT of the Articles of Incorporation of Airspan Communications Corporation (the "Corporation") are herein executed by said Corporation, pursuant to the provisions of RCW 23B.10.20 and RCW 23B.10.060, as follows:

FIRST: The name of the Corporation is Airspan Communications Corporation.

SECOND: Article 1 of the Articles of Incorporation is amended to read as follows:

The name of the corporation is Airspan Networks Inc.

THIRD: This amendment does not provide for an exchange, reclassification or cancellation of issued shares.

FOURTH: The date of the adoption of said Amendment by the Directors of said Corporation was the 4th day of November, 1999.

FIFTH: The amendment was adopted by resolution of the Board of Directors without shareholder action. Pursuant to RCW 23B.10.020(5), shareholder action is not required.
