OF

This Amended and Restated Certificate of Formation of Centeon L.L.C. (the "LLC"), dated December ~~27~~, 1999, has been duly executed and is being filed by John Bond, as an authorized person, in accordance with the provisions of 6 Del. C. § 18-208. This Amended and Restated Certificate of Formation is to be effective on January 1, 2000. The LLC was originally formed under the name Verion L.L.C., pursuant to a Certificate of Formation filed on May 15, 1995 with the Secretary of State of the State of Delaware (the "Certificate"). 
