US/UK TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (the "Assignment") is made as of the 11th day of April, 2001 between Stella N. McCartney, an individual resident in England ("McCartney"), and Precis (1995) Limited, a limited company incorporated and registered with registration No. 4169969 under the laws of England ("Newco").

WHEREAS, in furtherance of the transactions contemplated in the Agreement by and among McCartney, Newco, and Gucci Group N.V., a public limited company incorporated and existing under the laws of the Netherlands, dated as of April 8, 2001 (the "Newco Agreement"), McCartney has formed Newco to manufacture, market and distribute worldwide high-end luxury or designer goods in the classes listed in Exhibit A hereto (the "Products") under the McCartney Trademarks (as defined herein) on the terms and subject to the conditions of the Newco Agreement, thereby enhancing the value and goodwill of same. All terms not otherwise defined herein shall have the meanings ascribed to them in the Newco Agreement.

WHEREAS, "McCartney Trademarks" shall mean the Marks "Stella", "Stella McCartney", "Stella Nina McCartney", "Stella N. McCartney", "SNM", and "SM" including, without limitation, the trademark and service mark registrations and applications and internet domain names listed on Exhibit B hereto.

WHEREAS, Newco wishes to acquire all McCartney's right, title and interest in and to the McCartney Trademarks, in the United Kingdom and the United States (the "Territory"), including any goodwill inherent therein.

NOW, THEREFORE, for consideration of \$9,000,000, the parties agree as follows:

1. McCartney hereby sells, assigns, transfers, and conveys unto Newco all of McCartney's right, title and interest in and to the McCartney Trademarks, in the Territory, whether statutory or at common law or otherwise, including all applications and registrations thereof, together with any goodwill inherent therein, and the right to sue for, collect and retain all damages and profits and all other remedies for past infringements thereof effective as of the Closing.

2. At Newco's expense and reasonable request, McCartney shall cooperate fully with Newco to properly and completely effect the transfer to Newco

of the McCartney Trademarks, including, without limitation, executing such further assignments of the McCartney Trademarks or other documents as are deemed necessary or appropriate by Newco to effect and/or record such transfer in the United Kingdom and the United States.

3. At the requesting party's expense and reasonable request, the other party shall cooperate fully to enter into appropriate separate agreements acknowledging the value of the McCartney Trademarks transferred in particular jurisdictions within the Territory, if necessary or desirable to effectuate the purposes of this Assignment or to respond to any tax authority.

4. McCartney authorizes the Commissioner of Patents and Trademarks or the Registrar of Trademarks, as the case may be, to record the McCartney Trademarks as the property of Newco and to issue certificates of registration to Newco in Newco's name.

5. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same instrument.

6. This Assignment shall be governed by, and construed in accordance with, the laws of the State of New York, United States of America, applicable to contracts performed in that State.

7. Arbitration.

(a) all disputes, controversies or claims arising out of or in connection with this Assignment or the breach thereof, shall be finally settled by arbitration under the Rules of Arbitration of the International Chamber of Commerce then in effect, by three arbitrators appointed in accordance with such rules. The seat of arbitration shall be New York City, New York. The arbitration shall be conducted and the award shall be rendered in English. The arbitrators shall permit or require such discovery as they deem appropriate in the circumstances of the case, taking into account the need to conduct the proceedings expeditiously and fairly. The award shall be final and binding upon the parties. Judgment on the award may be entered in any court having jurisdiction.

(b) In order to facilitate the comprehensive resolution of related disputes, all claims between any of the parties to this Assignment that arise under or in connection with claims

under the Trademark Assignment dated the date hereof with respect to the rest of the world (the "Rest of the World Trademark Assignment"), the Newco Agreement or the Employment Agreement may be brought in a single arbitration. Upon the request of any party to an arbitration proceeding initiated under this Assignment, the Rest of the World Trademark Assignment, the Newco Agreement or the Employment Agreement, the arbitral tribunal shall consolidate such arbitration proceeding with any other arbitration proceeding involving any of the parties hereto relating to this Assignment, the Rest of the World Trademark Assignment, the Newco Agreement or the Employment Agreement if the arbitrators determine that (i) there are issues of fact or law common to the proceedings so that a consolidated proceeding would be more efficient than separate proceedings, and (ii) no party would be unduly prejudiced as a result of such consolidation through undue delay or otherwise. In the event of different rulings on this question by the arbitration tribunal constituted hereunder and a tribunal constituted under the Rest of the World Trademark Assignment, the Newco Agreement or the Employment Agreement, the ruling of the arbitration tribunal constituted first in time shall control, and such arbitral tribunal shall serve as the arbitral tribunal for any consolidated arbitration.

(c) By agreeing to arbitration, the parties do not intend to deprive any court of its jurisdiction to issue a pre-arbitral injunction, pre-arbitral attachment or other order in aid of arbitration proceedings and the enforcement of any award. Without prejudice to such provisional remedies as may be available under the jurisdiction of a court, the arbitral tribunal shall have full authority to grant provisional remedies or order the parties to request that a court modify or vacate any temporary or preliminary relief issued by a such court, and to award damages for the failure of any party to respect the arbitral tribunal's orders to that effect. Under no conditions may this Assignment be terminated, including by an arbitral tribunal or a court; provided that this Assignment shall not be read to limit or modify in any way the provisions of Section 10.01 (Termination) of the Newco Agreement.

(d) Each party shall bear all costs incurred by it in connection with arbitration proceedings pursuant to this Section 7,

provided however that so long as Gucci owns at least 50% of the voting Shares of Newco or otherwise has effective control over Newco, Gucci shall bear Newco's arbitration costs.




