ASSIGNMENT OF PROPRIETARY RIGHTS

This Assignment of Proprietary Rights (hereinafter referred to as "Assignment") is effective as of the 1st day of March, 2000, by and between Anthony Hawk, an individual having a residence at 4529 Adams Street, Carlsbad, CA 92008 (hereinafter referred to as "ASSIGNOR"), and Hawk Designs, Inc., a California corporation located at 15202 Graham Street, Huntington Beach, CA 92649 (hereinafter referred to as "ASSIGNEE").

WHEREAS, ASSIGNOR has adopted, used, is using, and is, to the best of its knowledge and belief, the sole and exclusive owner of the rights listed in Schedules A, B and C, attached hereto and incorporated herein by this reference, and all other rights appurtenant thereto, including, but not limited to, all common law rights, trade name rights, causes of action, copyright rights and the right to recover for past infringement (hereinafter collectively referred to as "Proprietary Rights") worldwide;

WHEREAS, ASSIGNOR has acquired goodwill associated with and symbolized by said Proprietary Rights and has not abandoned or assigned the same;

WHEREAS, ASSIGNOR is the owner of the United States trademark registration relating to the Trademark listed in Schedule B, attached hereto and incorporated herein by reference (hereinafter referred to as "U.S. Registration");

WHEREAS, ASSIGNOR is the owner of the foreign trademark applications and registrations relating to the Trademark listed in Schedule C, attached hereto and

incorporated herein by reference (hereinafter collectively referred to as "Foreign Applications and Registrations");

WHEREAS, ASSIGNEE is desirous of acquiring all rights, title, and interest in and to the Trademark, U.S. Registration, Foreign Applications and Registrations and any other registered or unregistered TONY HAWK marks owned or used by ASSIGNOR worldwide for apparel, headwear, footwear, back packs, duffle bags, wallets, key chains, and stickers; and

WHEREAS, ASSIGNOR is willing to assign to ASSIGNEE all rights, title, and interest that ASSIGNOR possess in and to the Trademark, U.S. Registration, Foreign Applications and Registrations, Proprietary Rights and any other registered or unregistered TONY HAWK trademarks owned or used by ASSIGNOR worldwide for apparel, headwear, footwear, back packs, duffle bags, wallets, key chains, and stickers;

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged by ASSIGNOR, ASSIGNOR hereby assigns and sells to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the following:

- (1) the Trademark set forth in Schedule A, the U.S. and Foreign Applications and Registrations set forth in Schedule B and Schedule C, and any other registered or unregistered trademarks owned or used anywhere in the world by ASSIGNOR for the mark TONY HAWK for apparel, headwear, footwear, back packs, duffle bags, wallets, key chains, and stickers; and

(2) the Proprietary Rights owned by ASSIGNOR worldwide for apparel, headwear, footwear, back packs, duffle bags, wallets, key chains, and stickers;

together with the goodwill symbolized by said Trademark, U.S. Registration, Foreign Applications and Registrations, and other registered or unregistered TONY HAWK trademarks owned or used anywhere in the world by ASSIGNOR for apparel, headwear, footwear, back packs, duffle bags, wallets, key chain, and stickers concurrent with the transfer of certain tangible assets as indicia of said goodwill.
