ASSIGNMENT OF TRADEMARKS

WHEREAS, Tosco Corporation, a Nevada corporation, located at 1700 East Putnam Avenue, Suite 500, Old Greenwich, Connecticut 06870 (hereinafter referred to as "ASSIGNOR"), is the owner of the U.S. Trademark Application 76/036,955 for the mark CIRCLEK.COM (hereinafter referred to as the "TRADEMARK"); and

WHEREAS Circle K Stores Inc., a Texas corporation, located at 1500 North Priest Drive, Tempe, Arizona 85281 (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring all of the right, title and interest of ASSIGNOR in, to and under the TRADEMARK, together with the goodwill of the business associated with the TRADEMARK;

ASSIGNOR acknowledges that upon execution of this Assignment, ASSIGNEE shall be the exclusive owner of the TRADEMARK; and

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States whose duty it is to record trademark registrations, applications and title thereto,

to record the TRADEMARK and title thereto as the property of the ASSIGNEE, its successors, legal representatives and assigns in accordance with the terms of this instrument; and

ASSIGNOR does also hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringement of the TRADEMARK, the right to sue for and collect the same for its own use and enjoyment and the use and enjoyment of its successors, assigns or other legal representatives;

ASSIGNOR further agrees to execute such further documents as may be required to record ASSIGNEE as the owner of the TRADEMARK herein assigned.
