CERTIFICATE

I, Hajo Bart Hendrik Kraak, civil-law notary in Amsterdam, hereby certify:

- by deed executed on the twenty-second day of September two thousand before me, civil-law notary:
 - a. the company with limited liability (*naamloze vennootschap*) Amsterdam Exchanges N.V., with official seat in Amsterdam, having its office in 1012 JW Amsterdam, Beursplein 5 and filed in the Trade Register under number 33287100;
 - b. the company with limited liability (*naamloze vennootschap*) Euronext Amsterdam N.V., with official seat in Amsterdam, having its office in 1012 JW Amsterdam, Beursplein 5 and filed in the Trade Register under number 34138585; and
 - c. the company with limited liability (*naamloze vennootschap*) Euronext N.V., with official seat in Amsterdam, having its office in 1012 JW Amsterdam, Beursplein 5 and filed in the Trade Register under number 34137761, entered into a merger within the meaning of Chapters 1, 2 and 3 of Part 7, Book 2, Dutch Civil Code, implemented by way of a three-way legal merger pursuant to article 2:334 Dutch Civil Code;
- on the date such merger became effective, being the twenty-third day of September two thousand:
 - a. Euronext Amsterdam N.V., pursuant to article 2:309 Dutch Civil Code, acquired all assets and liabilities of Amsterdam Exchanges N.V. under universal succession of title (*algemene titel*);
 - b. Amsterdam Exchanges N.V. ceased to exist; and
 - c. the shareholders of Amsterdam Exchanges N.V. received shares in the capital (and thus became shareholders) of Euronext N.V. rather than Euronext Amsterdam N.V., pursuant to article 2:334 Dutch Civil Code;



- for purpose of such merger, Euronext Amsterdam N.V. had been newly incorporated on the fourth day of August two thousand by a deed executed before H.B.H. Kraak, civil-law notary in Amsterdam, as a wholly subsidiary of Euronext N.V.

Signed in Amsterdam on the sixth day of December two thousand.
