**1. DEFINITIONS**

Products means knitwear, textiles and other garments made and/or sold by the Assignor in the course of its business; and

Schedule means the Schedule annexed to and forming part of this Agreement.

## 2. ASSIGNATION

The Assignor hereby assigns to the Assignee all its property right title and interest in the Intellectual Property Rights, and hereby undertakes at the request and cost of the Assignee to execute all such further documents, forms and authorisations as may be required to vest full right title and interest in the Intellectual Property Rights in the Assignee absolutely, including but not limited to registration of the Assignee's title as proprietor at relevant trade mark registries anywhere in the world.

## 3. WARRANTIES

3.1 The Assignor hereby warrants represents and undertakes to the Assignee as follows:-

(a) it has full power to enter into and perform this Assigantion, and this Assigantion constitutes binding obligations on it in accordance with its terms; and

(b) the Intellectual Property Rights which are the subject of registration are its sole absolute property free from encumbrances, free and clear of any security interest or third party rights.
