CERTIFICATE OF INCORPORATION OF

GuruNet Corporation, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation")

**DOES HEREBY CERTIFY:**

**FIRST:** The name of the Corporation is GuruNet Corporation.

**SECOND:** The date on which the Certificate of Incorporation of the Corporation was originally filed with the Secretary of State of the State of Delaware is March 10, 1999, under the name of Guru International, Inc.

**THIRD:** That by unanimous written consent, the Board of Directors of the Corporation adopted a resolution setting forth a proposed amendment to the Amended and Restated Certificate of Incorporation of the Corporation (the "Certificate"), declaring said amendment to be advisable and in the best interests of the Corporation and its stockholders and authorizing the appropriate officers of the Corporation to solicit the consent of the stockholders therefor, which resolution setting forth the proposed amendment is as follows:

**"RESOLVED,** that Article I of the Amended and Restated Certificate of Incorporation of the Corporation be amended to read in full as follows:

**ARTICLE I**

The name of this corporation is Atomica Corporation."

**FOURTH:** That thereafter said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law by written consent of the stockholders holding the requisite number of shares required by statute given in accordance with and pursuant to Section 228 of the General Corporation Law of the State of Delaware.
