RELEASE OF ONE TRADEMARK REGISTRATION FROM SECURITY AGREEMENT

WHEREAS, BOLLE AMERICA, INC., a Delaware corporation, by a Security Agreement dated _____ and recorded in the U.S. Patent and Trademark Office on February 15, 2000, at Reel 2036/0574, granted to ANTARES CAPITAL CORPORATION, an Illinois corporation, of Chicago, Illinois, a security interest in certain intellectual property assets, including trademark registrations owned by BOLLE, to secure the indebtedness owing from BOLLE to Antares; and
