TERMINATION OF COLLATERAL ASSIGNMENT OF TRADEMARK

This **TERMINATION OF COLLATERAL ASSIGNMENT OF TRADEMARK** (this "Agreement") is made as of the 30 day of April, 2001, by and between American National Bank and Trust Company of Chicago (as successor in interest to Bank One, Wisconsin) ("ANB"), and Tamms Industries, Inc., a Delaware corporation ("Tamms").

RECITALS

A. Tamms granted to ANB a collateral assignment of the trademark DURAL, which was registered with the United States Patent and Trademark Office on January 28, 1986, bearing registration number 1,379,870, including without limitation all proceeds thereof (such as, by way of example, license royalties and proceeds of infringement suits), the right to sue for past present and future infringements, all rights corresponding thereto throughout the world and all royalties, continuations, renewals, extensions and goodwill associated therewith (collectively the "Trademark"), pursuant to that certain Collateral Assignment dated March 4, 1997 ("Collateral Assignment").

B. Tamms desires to terminate the Collateral Assignment with respect to the Trademark, and ANB is willing to so terminate the same, in consideration of the terms and conditions of this Agreement.

NOW, THEREFORE, in consideration of the agreements herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and the parties intending to be legally bound, agree as follows:

1. The Collateral Assignment to ANB (with respect to the Trademark) is terminated as of April 30, 2001.

2. The Commissioner of Patents and Trademarks is respectfully requested to record this Agreement in the United States Patent and Trademark Office against the file herein described.
