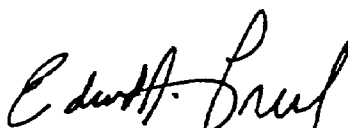

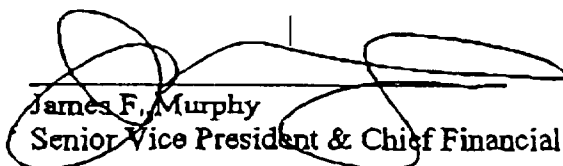
RESOLVED: That the Certificate of Incorporation of the Corporation be and hereby is amended by deleting Article First in its entirety and substituting therefor the following:
