



VIVID is the sole and exclusive owner of the trademarks that are the subject of the trademark registrations listed below:

1. Reg. No. 2,019,637, registered November 26, 1996, for the mark "Vivid, and design", registered in Intl. Cl. 9, for "integrated circuits"; and
2. Reg. No. 2,089,520, registered August 19, 1997, for the mark "VIVID SEMICONDUCTOR", registered in Intl. Cl. 9, for "integrated circuits";

the trademarks listed above as items 1 and 2 being referred to herein as "the registered marks".

VIVID is the sole and exclusive owner of the pending intent-to-use U.S. trademark application identified below:

3. U.S. Trademark Application Ser. No. 75/527,832, filed on July 30, 1998, seeking registration of the mark "WHISPERBUS", in Intl. Cl. 9, for "integrated circuits", for which a Notice of Allowance was issued on August 10, 1999;

the trademark application identified above as item 3 being referred to herein as "the pending U.S. trademark application".

The registered marks and the pending U.S. trademark application are hereinafter collectively referred to as "Trademark Rights".

Pursuant to that certain Assignment of Seller Proprietary Rights executed by VIVID on August 9, 2000, VIVID agreed to sell, transfer, and assign, and did sell, transfer, and assign said Trademark Rights to NATIONAL.

VIVID has sold to NATIONAL the portion of VIVID's business to which the mark "WHISPERBUS" pertains, which business is ongoing and existing, and NATIONAL is the successor to such business.

VIVID now desires that the aforementioned assignment of said Trademark Rights be set forth in a form that can be recorded in the U.S. Patent and Trademark Office.

NOW, THEREFORE, in consideration of the above, and in consideration of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, VIVID agrees as follows:

1. VIVID does hereby sell and assign to NATIONAL, its successors and assigns, the entire right, title and interest in and to the above-identified Trademark Rights, including:

a. the entire right, title and interest in and to the registered marks "Vivid, and design" as shown in Reg. No. 2,019,637, for "integrated circuits", and "VIVID SEMICONDUCTOR" for "integrated circuits", any issued state or Federal trademark registrations or foreign trademark registrations directed to the registered marks, as well as any pending applications therefor, together with the goodwill of the integrated circuit business symbolized by the registered marks; and

b. the entire right, title and interest in and to the trademark "WHISPERBUS" for use with "integrated circuits", including all rights in the pending U.S. trademark application identified above, any issued state or Federal trademark registrations or foreign trademark registrations directed to such trademark, as well as any pending applications therefor, together with the portion of VIVID's integrated circuit business to which the mark "WHISPERBUS" pertains, and any goodwill of the integrated circuit business currently symbolized by such mark;

2. VIVID covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith, and that it is unaware of any liens or security interests held by third parties in the Trademark Rights.

3. VIVID hereby agrees upon request and without further consideration, but at the expense of NATIONAL: (a) to communicate to NATIONAL, or its representatives or nominees, any facts known to VIVID relating to the above-identified Trademark Rights; (b) to testify in any legal proceeding relating to the above-identified Trademark Rights; (c) to sign and execute all

lawful papers and to make all lawful oaths relating to the above-identified Trademark Rights; and (d) to perform all acts reasonably necessary to aid NATIONAL, its successors, assigns and nominees in obtaining, maintaining, and enforcing trademark protection in the United States and foreign countries for the above-identified Trademark Rights.

4. The Trademark rights being assigned hereby shall be held and enjoyed by NATIONAL for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by VIVID if this assignment and sale had not been made, together with all claims for damages by reason of past infringement, with the right to sue and collect for such claims for NATIONAL's own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives.

5. VIVID hereby authorizes and requests any official whose duty it is to issue trademark registrations to issue any trademark registration or renewal thereof which may be based upon the above-identified Trademark Rights to NATIONAL or its successors or assigns.
