Pursuant to Section 252 of the General Corporation Law of the State of Delaware ("Section 252"), NationsBank Corporation, a North Carolina corporation ("NationsBank"), and NationsBank (DE) Corporation, a Delaware corporation ("NationsBank (DE)"),

DO HEREBY CERTIFY:

FIRST: That the name and state of incorporation of each of the constituent corporations of the merger herein certified is as follows:

<u>Name</u>	<u>State of Incorporation</u>
NationsBank Corporation	North Carolina
NationsBank (DE) Corporation	Delaware

SECOND: That an agreement of merger (the "Plan of Reincorporation Merger") between the parties to the merger herein certified (the "Merger") has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with the requirements of Section 252 of the General Corporation Law of the State of Delaware.

THIRD: That the surviving corporation of the Merger is NationsBank (DE) Corporation, Delaware corporation.

FOURTH: That the Certificate of Incorporation of the surviving corporation shall be the Certificate of Incorporation of NationsBank (DE) Corporation, except that Article 1 thereof shall be amended to read in full as follows: "The name of the Corporation is NationsBank Corporation."

FIFTH: That the executed Plan of Reincorporation Merger is on file at an office of the surviving corporation. The address of this office is NationsBank Corporate Center; 100 N. Tryon St.; Charlotte, North Carolina 28255.

**SIXTH:** That a copy of the Plan of Reincorporation Merger will be furnished by the surviving corporation, on request and without cost, to any stockholder of any constituent corporation.

**SEVENTH:** That the authorized capital stock of NationsBank Corporation is 1,250,000,000 shares of common stock, without par value, and 45,000,000 share of preferred stock, without par value.


