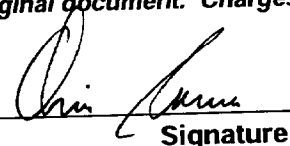

AMENDMENT TO THE ARTICLES OF INCORPORATION OF BAXTER RESEARCH MEDICAL, INC. (a Utah corporation)

Pursuant to Section 16-10a-1006 of the Utah Revised Business Corporation Act, as amended, Baxter Research Medical Inc. hereby submits the following Amendment to the Articles of Incorporation:

FIRST: The name of the Corporation is Baxter Research Medical, Inc.

SECOND: Article 1 to the Articles of Incorporation is hereby amended to read as follows:

ARTICLE 1

"The name of the Corporation is: Edwards Lifesciences Research Medical, Inc."

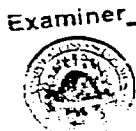
THIRD: The above amendment was unanimously adopted by consent of the Board of Directors of the Corporation as of February 24, 2000.
