WHEREAS, Avesta Technologies, Inc. (hereinafter "Assignor"), a corporation organized under the laws of the State of Delaware, and located at 2 Rector Street, New York, New York 10006, had acquired all of the rights, title and interest in and to the trademark TRANSCIVE possessed by Caravelle Inc., a Canadian corporation located at 210 Colonnade Road, South Suite 301, Nepean, Ontario K2E 7L5, Canada, which mark registered on the Principal Register on December 2, 1997, and was assigned Registration No. 2,117,886; and

WHEREAS, effective May 24, 2000, Visual Networks Technologies, Inc. (hereinafter "Assignee"), a corporation organized under the laws of the State of California, and located at 2092 Gaither Road, Rockville, Maryland 20850, acquired all of Assignor's rights, title, goodwill and interest in and to the trademark.

NOW, THEREFORE, in consideration of and in exchange for the sum of ten dollars (\$10.00) and other good and valuable consideration, receipt of which has been acknowledged, said Assignor hereby assigned unto said Assignee all of Assignor's rights, title and interest in and to the trademark together with all of Assignor's goodwill of the business symbolized by the trademark.

AFFIDAVIT

I, Robert Kostas, hereby declare that:

1. I have personal knowledge of the matters set forth in this Affidavit and, if called as a witness in this matter, could and would competently testify thereto.

2. I was an officer of Avesta Technologies, Inc. (hereinafter "Avesta"), a corporation organized under the laws of the State of Delaware, and located at 2 Rector Street, New York, New York 10006. I held the position of Vice President of Research and Development for Avesta.

3. Prior to June 9, 1998, Caravelle Inc. (hereinafter "Caravelle") was a Canadian corporation located at 210 Colonnade Road, South Suite 301, Nepean, Ontario K2E 7L5, Canada. Caravelle had adopted and used the mark TRANSCEIVE and had acquired goodwill in connection with such use. Caravelle had acquired a U.S. federal trademark registration for the mark TRANSCEIVE and was the named registrant for the mark, which registered on the Principal Register on December 2, 1997, and was assigned Registration No. 2,117,886.

3. On or about June 9, 1998, Avesta purchased Caravelle and all assets of Caravelle, including all of Caravelle's rights, title, goodwill and interest in and to the trademark TRANSCEIVE and the registration therefor.


4. On or about May 24, 2000, Avesta was purchased by Visual Networks Technologies, Inc. (hereinafter "Visual Networks"), a corporation organized under the laws of the State of California, and located at 2092 Gaither Road, Rockville, Maryland 20850, and thereby acquired all of Avesta's rights, title, goodwill and interest in and to the trademark TRANSCEIVE and the

registration therefor. Consequently, Visual Networks is the present owner of the trademark

TRANSCIVE, possessing all rights, title, interest and goodwill conveyed by Avesta.
