

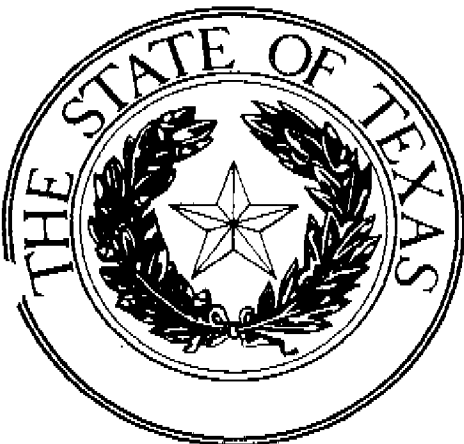

Pursuant to the provisions of Section 4.04 of the Texas Business Corporation Act, the undersigned adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE: The name of the corporation is Union Carbide Industrial Services Corporation.

ARTICLE TWO: The following amendment to the Articles of Incorporation was adopted by the corporation on June 12, 1992:

Article One of the Articles of Incorporation is hereby amended so as to read as follows:


"The name of the Corporation is UCISCO, Inc."

ARTICLE THREE: The number of shares of the corporation outstanding at the time of such adoption was 2,200; and the number of shares entitled to vote thereon was 2,200.

ARTICLE FOUR: The holders of all of the shares outstanding and entitled to vote on said amendment have signed a consent in writing adopting such amendment.
