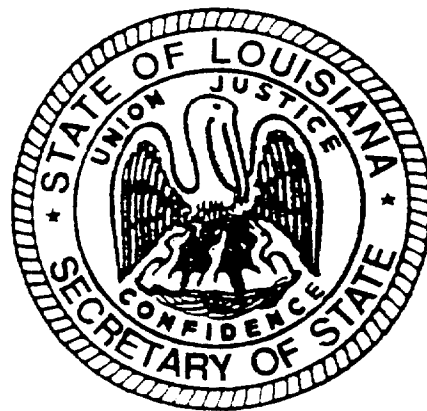

(Filed Pursuant to Section 112F of the Louisiana Business Corporation Law)

The undersigned corporation, acting pursuant to Section 112F of the Louisiana Business Corporation Law (the "LBCL"), hereby certifies that:

1. The name and state of incorporation of each of the corporations that is a party to the merger to which this certificate relates (the "Constituent Corporations") is as follows:

Superior Well Service, Inc.	Louisiana

2. An Agreement and Plan of Merger between the Constituent Corporations (the "Agreement") providing for the merger (the "Merger") of Cardinal Services, Inc. ("Cardinal") with and into Superior Well Service, Inc. ("Superior Well"), has been approved, adopted, certified, executed and acknowledged by each of the Constituent Corporations in accordance with the requirements of Section 112 of the LBCL.

3. At the Effective Time (as defined in paragraph 7), Cardinal will merge with and into Superior Well, which shall be the surviving corporation (the "Surviving Corporation"), and the separate existence of Cardinal shall cease.

4. The Articles of Incorporation, Bylaws, directors and officers of Superior Well as of the Effective Time shall be the Articles of Incorporation, Bylaws, directors and officers of the Surviving Corporation.

5. A copy of the executed Agreement is on file at the principal place of business of the Surviving Corporation, located at 1105 Peters Road, Harvey, Louisiana 70058.


6. A copy of the Agreement will be furnished by the Surviving Corporation, on request and without cost, to any shareholder of any corporation that is a party to the Merger.






