

**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
IRRIGATION SUPPLY COMPANY, INCORPORATED
(changing name to ISCO Industries, Inc.)**

To the Secretary of State of the Commonwealth of Kentucky:

The undersigned, the President of Irrigation Supply Company, Incorporated, a Kentucky corporation, states as follows:

- 1. The name of the corporation is Irrigation Supply Company, Incorporated.
- 2. The first paragraph of the Articles of Incorporation is amended to read as follows:

The name of the Corporation is ISCO Industries, Inc.

- 3. The Amendment does not provide for an exchange, reclassification, or cancellation of issued shares.
- 4. The Amendment was adopted by the Shareholders on September 20, 1996.
- 5. (a) The authorized shares of the corporation entitled to vote on the Amendment are designated as Class A Common Stock. The number of outstanding shares of Class A Common Stock is 50, all of

which are entitled to vote, and all of which were represented at the meeting.


(b) The total number of votes cast for the Amendment was 50; there were no votes against the Amendment.
