RELEASE AND TERMINATION OF  
ASSIGNMENT AND SECURITY INTEREST

WHEREAS, on or about September 29, 1997, Stephen L. 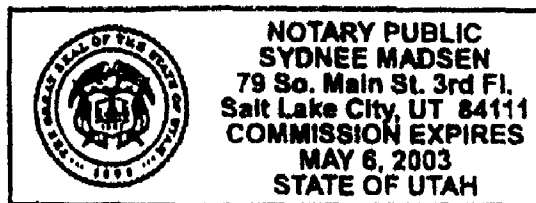
