CERTIFICATE OF INCORPORATION OF

TOTAL NETWORK SOLUTIONS, INC.

Under Section 805 of the Business Corporation Law

The undersigned, being the President of Total Network Solutions, Inc.; do hereby certify as follows:

1. The name of the corporation is Total Network Solutions, Inc. (the "Corporation").
2. The certificate of incorporation of the Corporation was filed by the Department of State on December 23, 1993.

The Certificate of Incorporation of the Corporation is hereby amended to change the name of the Corporation to "ThruPoint, Inc." and to clarify the limitations on the voting rights of the Corporation's Series C Convertible Preferred Stock. Article FIRST of the Corporation's Certificate of Incorporation is hereby amended to read in its entirety as follows:

FIRST: The name of the Corporation is ThruPoint, Inc.


and paragraph E.9(c) of Article FOURTH of the Corporation's Certificate of Incorporation is amended to read in its entirety as follows:

Notwithstanding the foregoing provisions of this paragraph E.9, the Series C Preferred Stock will have voting rights only to the extent that outstanding amounts under the Series C Note have been converted into a number of shares of Common Stock (adjusted for stock splits, stock dividends, recombinations and other similar events) that exceeds the number of shares of Common stock issuable upon conversion of the Series C Preferred Stock issued pursuant to the Series C Convertible Preferred Stock Purchase Agreements dated as of December 21, 1999 and February 3, 2000 among the Corporation and the investors signatory thereto.

3. The amendment was authorized by resolution of the board of directors of the Corporation at a duly convened meeting followed by written consent of the holders of the majority of all outstanding shares of the Corporation entitled to vote
