Dear Sirs,

We refer to the Credit Facilities Agreement dated as of July 2, 1999, between Financière Moulins de Champagne as Original Borrower, G.H. Mumm & Cie–Société Vinicole de Champagne, Successeur (“**G.H. Mumm & Cie**”) and Champagne Perrier Jouët (“**Perrier Jouët**”) as Acceding Borrowers, BNP Paribas (formally “Paribas”) as Coordinator, Lead Arranger and Agent, Warburg Dillon Read as Co-Lead Arranger and Deutsche Bank AG, London as Co-Arranger and various Banks party thereto, as amended by the Waiver and Amendment No.1 dated August 25, 2000 (the “**Credit Facilities Agreement**”). Terms defined in the Credit Facilities Agreement shall have the same meanings herein.

We also refer to the letter dated January 22 2001, providing *inter alia*, that upon prepayment in full of the Loans together with all amounts outstanding under the Credit Facilities Agreement (the “**Prepayment**”), the pledges, transfers, assignments and charges and any other security constituted by the Security Documents (as listed in Schedule 1 to this letter) shall be unconditionally and irrevocably released.

With respect to the Prepayment which occurred on the date hereof, we hereby confirm, for the purposes of the formalities to be conducted with respect to the release of the pledge constituted over certain trademarks held by G.H. Mumm & Cie and Perrier Jouët, that the Credit Parties to (i) the Trademark Pledge Agreement between G.H. Mumm & Cie and the Agent dated July 2, 1999 and to (ii) the Trademark Pledge Agreement between Perrier Jouët and the Agent dated July 2, 1999 (together the “**Trademark Pledge Agreements**”), are released and discharged from all obligations thereunder (other than ongoing indemnity obligations). Consequently, we hereby confirm and authorize the release of any existing pledges over the Pledged Trademarks, as defined in the Trademark Pledge Agreements. The

pertinent trademark registrations/applications held by G.H. Mumm & Cie are listed in Exhibit 1 hereto, and the pertinent trademark registrations/applications held by Perrier-Jouët are listed in Exhibit 2 hereto, both of which exhibits were constituted on the basis of the Trademark Pledge Agreements.


