TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby confirms the sale and assignment, and by these presents does hereby sell, assign and transfer to Assignee, its successors and assigns, absolutely and forever, the entire right, title and interest, whether statutory or at common law, in and to SAID MARK and SAID REGISTRATIONS, together with the goodwill of the business symbolized by SAID MARK and SAID REGISTRATIONS, together with all causes of action for any and all previously occurring infringement of the rights being assigned and the right to receive and retain the proceeds or other remedies relating to those infringements.

Assignor agrees to execute further papers and to do such other acts as may be necessary or

desirable to vest full right, title and interest in and to SAID MARK and SAID REGISTRATIONS in Assignee or as may be necessary or desirable to obtain, renew, issue or enforce SAID MARK and SAID REGISTRATIONS.

This assignment and sale is made effective July 26, 2000.
