CONFIRMATION OF TRADEMARK ASSIGNMENT AND ASSIGNMENT

This Trademark Assignment ("Assignment") is effective as of the 21st day of December, 1999, by and between Marker Deutschland GmbH, a German corporation, and Marker International GmbH, a Swiss corporation (collectively referred to as "ASSIGNOR"), and Split Inc., a California corporation formerly known as Split Ltd., a California limited partnership (collectively referred to as "ASSIGNEE").

WHEREAS, ASSIGNOR adopted and used, and, to the best of its knowledge and belief, was the owner of the trademark listed in Schedule A, attached hereto and incorporated herein by reference, and all other rights appurtenant thereto, including, but not limited to, all common law rights, trade name rights, causes of action, and the right to recover for past infringement worldwide (collectively referred to as "Trademark");

WHEREAS, ASSIGNOR acquired goodwill associated with and symbolized by said Trademark and obtained applications and registrations for the Trademark (collectively referred to as "Registrations") as set forth in Schedule A; and

WHEREAS, ASSIGNEE was and is desirous of acquiring all rights, title, and interest in and to the Trademark and Registrations; and

WHEREAS, on August 6, 1999 ASSIGNEE and ASSIGNOR entered into an agreement effective July 1, 1999, concerning the assignment of the Trademark and Registrations; and

WHEREAS, on December 21, 1999 ASSIGNOR confirmed payment to it of 30,000 Deutsche Marks by ASSIGNEE, and did assign to ASSIGNEE all rights, title, and interest as ASSIGNOR possessed in and to the Trademark and Registrations worldwide;


