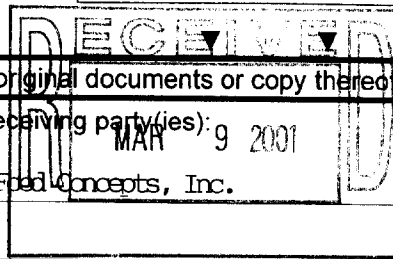

SECURITY INTEREST RELEASE
