ACKNOWLEDGMENT

WHEREAS, FIT TV Holdings, LLC (the "Company"), a limited liability company organized under the laws of the State of Delaware, was a partner in FIT TV Partnership ("FIT TV Partnership"), a Delaware general partnership; and

WHEREAS, on or about April 25, 2000, FIT TV Partnership redeemed (the "Redemption") all of the outstanding partnership interests of FIT Partners, which at such time was the only other partner in FIT TV Partnership, and as a result of the Redemption, FIT Partners ceased having any rights and privileges as a partner of FIT TV Partnership; and
