#### TRADEMARK SECURITY AGREEMENT

WHEREAS, UNAPIX ENTERTAINMENT, INC., a Delaware corporation, UNAPIX PRODUCTIONS WEST, a California corporation, FRESH DEVELOPMENT, INC., a Delaware corporation, UNAPIX ONLINE, INC., a New Jersey corporation formerly known as Unapix Direct Media, Inc., GREEN LEAF ADVERTISING COMPANY, INC., a New York corporation, UNAPIX SYNDICATION INC., a New York corporation, and PACIFIC SURF PRODUCTIONS, a California corporation, each a debtor and debtor-in-possession under Chapter 11 of the Bankruptcy Code (individually a "Grantor" and collectively, the "Grantors") have entered into a Debtor-In-Possession Credit and Security Agreement dated as of November 30, 2000 (the "Credit Agreement"), with General Electric Capital Corporation ("Lender"), pursuant to which the Lender has agreed to make loans to the Grantors subject to the terms and conditions set forth therein; and

WHEREAS, pursuant to the terms of the Credit Agreement, the Grantors have granted to the Lender a security interest in all of the personal property of the Grantors to secure the payment of the Obligations (as such term is defined in the Credit Agreement), which personal property includes without limitation all right, title and interest of the Grantors in, to and under any of the following, whether now owned or hereafter acquired (collectively, the "Trademarks"): (a) all trademarks, trade names, corporate names, business names, trade styles, service marks, logos, other source or business identifiers, prints and labels on which any of the foregoing have appeared or appear, designs and general intangibles of like nature (whether registered or unregistered), now owned or existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, including registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state or territory thereof, or any other country or any political subdivision thereof, including without limitation all of the trademarks listed in Schedule A attached hereto (as such Schedule may be amended from time to time by the addition of Trademarks subsequently registered or otherwise adopted or acquired); (b) all reissues, extensions or renewals thereof; and (c) all goodwill associated with or symbolized by any of the foregoing, whether now existing or hereafter arising or acquired, and all proceeds thereof;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the undersigned, hereby agree as follows:

1. The Grantors hereby jointly and severally grant to Lender, together with its successors and assigns, for security pursuant to the terms of and in connection with the Credit Agreement and related documents, a continuing security interest in all right, title and interest of each and all of the Grantors in and to the following (all of the following items or types of property being collectively referred to herein as the "Collateral"), whether presently existing or hereafter arising or acquired:

- (i) each Trademark and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, including without limitation each Trademark referred to in Schedule A annexed hereto:
- (ii) each Trademark license, including without limitation each Trademark license referred to in <u>Schedule B</u> annexed hereto, to the extent such Trademark license does not prohibit the licensee from assigning or granting a security interest in its rights thereunder; and
- (iii) all products and proceeds of, and income from, any of the foregoing, including without limitation any claim by any Grantor against third parties for the past, present or future infringement or dilution of any Trademark or any Trademark licensed under any Trademark license, or for injury to the goodwill associated with any Trademark.


