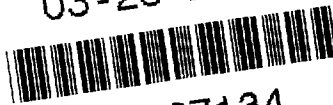

This Assignment made this 21st day of February 2001, effective as of the 1st day of July, 1999, by and between Research Centre of Kabbalah and Oroz, LLC.

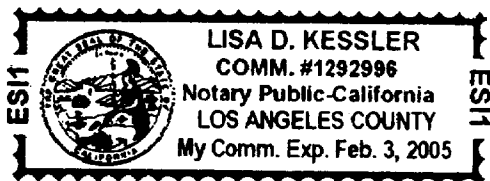
