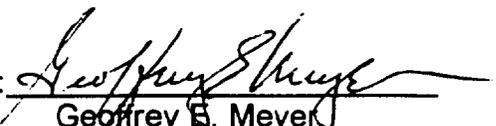
The name of the corporation is **FiberVisions Incorporated** (hereinafter the "Corporation").
