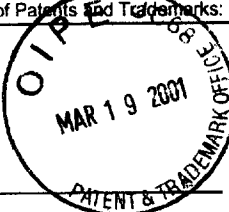

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, as set forth in that certain Trademark Assignment Agreement dated _____ March 14 _____, 2001 between Assignor and Assignee, said Assignor does hereby sell, assign, set over and transfer unto said Assignee, the entire right, title and interest in and to the ASSIGNED MARK and the identified U.S. registration therefor, together with the goodwill of the business pertaining thereto, the same and the rights of Assignor to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal

representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made.
