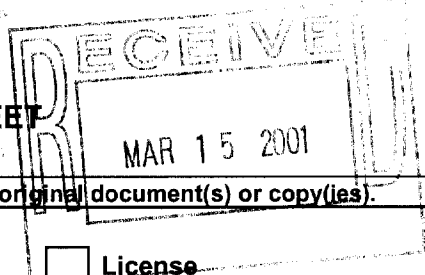


CERTIFICATE OF AMENDMENT
