ASSIGNMENT OF FEDERAL INTENT-TO-USE APPLICATION

WHEREAS, Thomson Finance S.A. ("Assignor"), a Luxembourg corporation, having a place of business at Weinbergstrasse 5, CH 6300 Zug, Switzerland, intended to use the mark **QRP QUALITY RECYCLED PARTS** in commerce and filed an application, now assigned Serial No. 75/784,566, with the United States Patent and Trademark Office under Section 1(b) of the Trademark Act, indicating that intention, but had not yet filed an allegation of use under Sections 1(c) or 1(d) of the Trademark Act, and

Section 1060; and

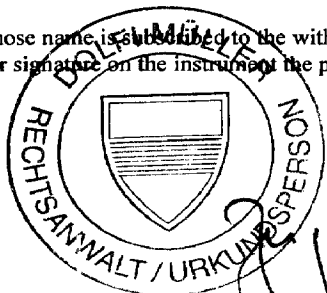
