

RELEASE OF TRADEMARK AND PATENT SECURITY INTEREST

This **RELEASE OF TRADEMARK AND PATENT SECURITY INTEREST** (this "**Release**") is executed this 5th day of March, 2001 by **THE CIT GROUP / BUSINESS CREDIT, INC.** ("**Secured Party**").

RECITALS:

A. Pursuant to a certain Loan Agreement executed between the Secured Party and Polyloom Corporation of America ("**Owner**") on November 23, 1998 ("**Loan Agreement**"), the Secured Party made certain loans to Owner (the "**Loans**").

B. In conjunction with the Loan Agreement the parties executed a Trademark and Patent Security Agreement dated November 23, 1998 ("**Security Agreement**"), pursuant to which the Owner granted a security interest to Secured Party in certain trademarks, tradenames, terms and designs ("**Trademarks**") and certain patents ("**Patents**"), including the U.S. federal trademark registrations and patents specified in **Schedule A** hereto.

C. The Security Agreement was recorded in the U.S. Patent and Trademark Office on December 10, 1998, at reel/frame 1778/0470 and 9414/0817.

D. The indebtedness arising under the Loan Agreement and secured by the Trademarks and Patents having been satisfied in full, the Secured Party is obligated to release the Trademarks and Patents from the liens, security interests, and other rights arising under the Security Agreement.

RELEASE:

NOW THEREFORE, for good and valuable consideration, the receipt and legal sufficiency of which are acknowledged, Secured Party hereby **RELEASES AND FOREVER DISCHARGES** any and all liens, security interests, titles, assignments, and other rights against the Trademarks and Patents, arising pursuant to or otherwise evidenced by the Security Agreement and any other documents securing the Loan, and hereby **RECONVEYS, REASSIGNS, TRANSFERS AND DELIVERS** to the Owner all rights with respect to the Trademarks and Patents, and any and all other rights, titles, and interests heretofore assigned and transferred unto the Secured Party pursuant to the Security Agreement and, to the extent relating to the Trademarks and Patents, pursuant to any other documents securing the Loan. This Release shall be binding upon Secured Party and Secured Party's successors and assigns and shall inure to the benefit of Owner and Owner's successors and assigns, and any present or future owner of any interest in the Trademarks and Patents.
