

RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of November __, 2000 by IMPERIAL BANK ("LENDER") to CARR SEPARATIONS, INC., a Delaware corporation, as successor in interest by merger to Carr Separations, Inc., a Massachusetts corporation ("COMPANY").
