CORRECTIVE ASSIGNMENT OF TRADEMARKS

WHEREAS, CAE Ransohoff, Inc., a Delaware corporation, having its principal offices at 4933 Provident Drive, West Chester, Ohio 45069, has succeeded to the business, assets and appurtenant goodwill of Ransohoff Company, a Delaware corporation, f/k/a (via merger) The Ransohoff Company, a Michigan corporation, f/k/a (via change of name) Avenir Industrial Corporation II, a Michigan corporation;

WHEREAS, by virtue of such successions, CAE Ransohoff, Inc., *inter alia*, owns all right, title and interest in and to the U.S. Trademark Registrations Nos. 1,266,765; 1,220,571; and 694,510, together with the goodwill symbolized by such trademarks;

WHEREAS, although an express assignment of Ransohoff Company's right, title and interest in the aforementioned trademark registrations was not legally necessary, Ransohoff Company nevertheless executed that certain Assignment of Registered Trademark or Pending Application to Successor Company, dated December 21, 1995 (the "Assignment"), a copy of which is attached hereto, recorded with the United States Patent and Trademark Office at Reel No. 1505, Frame No. 0977, pursuant to which the Ransohoff Company (erroneously referenced therein as "Ransohoff, Inc.") expressly assigned to CAE Ransohoff, Inc. all of its right, title and interest in and to aforementioned trademark registrations; and



NOW, THEREFORE, the Assignment is amended as follows:

2. The effective date of the Assignment shall be amended to be January 10, 1996.
