Trademark hereby assigned, all without further compensation to Assignor.

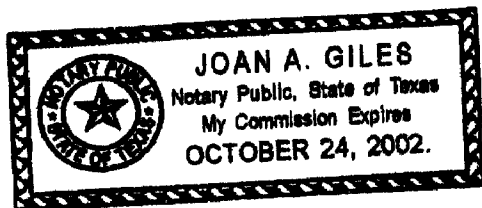


