NOTICE OF SECURITY AGREEMENT

NOTICE dated as of February 19, 2001, of certain security interests in certain intellectual property as set forth in a Security Agreement made by WORLDO.COM, INC., a Delaware corporation ("Debtor") with principal offices at 33 West 60th Street, 7th Floor, New York, New York, 10025, in favor of EASTON HUNT CAPITAL PARTNERS, L.P., a Delaware limited partnership ("Easton") with offices at 641 Lexington Avenue, 21st Floor, New York, New York, 10022, SANDER PARTNERSHIP, LLC a New York limited liability company with offices at 33 West 60th Street, New York, New York 10023 ("Sander") and RON W. 
