**RELEASE OF SECURITY AGREEMENT
AND ASSIGNMENT**

WHEREAS, LA FRANCAISE BAKERY, INC., an Illinois corporation, having a place of business at 111 North Northwest Avenue, North Lake, Illinois 60164, (hereinafter referred to as "LA FRANCAISE"), and LaSALLE BANK NA, formerly LaSalle North West National Bank, having a principal place of business at 135 South LaSalle Street, Chicago, Illinois 60603, (hereinafter referred to as "LaSALLE") entered into a certain Trademark Security Agreement dated December 16, 1996 (the "Security Agreement");

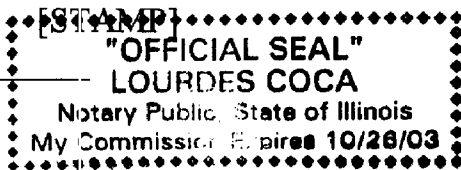
