TRADEMARK ASSIGNMENT

WHEREAS, COHERENT, INC., a Delaware corporation, having a business address at 5100 Patrick Henry Drive, Santa Clara, California 95054 (hereinafter referred to as "Assignor"), and ESC Medical Systems, Inc., a Massachusetts corporation, having a business address at 100 Morse Street, Norwood, Massachusetts 02062 (hereinafter referred to as "Assignee") have entered into that certain Asset Purchase Agreement dated as of February 25, 2001 pursuant to which Assignor has agreed, among other things, to transfer to Assignee all of its right title and interest in and to the Trademarks, as defined in that Asset Purchase Agreement, including but not limited to the Trademarks in the U.S.A. identified in the "Trademark Properties Schedule" attached hereto and made a part hereof (hereinafter collectively referred to as "US Trademarks").

WHEREAS, desires to acquire all of Assignor's right, title and interest in and to the US Trademarks;

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign, transfer, grant, free and clear of all lien, pledge, mortgage, charge, claim, title and encumbrance and set over exclusively to Assignee, its successors, legal representatives and assigns, its entire right, title and interest in and to the US Trademarks, together with the good will of the business associated with the said US Trademarks, and all causes of action relating thereto. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any official of any country or countries foreign to the United States whose duty it is to issue trademark registrations, to record this Assignment and to record the US Trademarks as the property of Assignee.

And the Assignor, on behalf of itself, its representatives and administrators, hereby covenants and agrees to do all such lawful acts and things and to execute without further consideration such further lawful assignments, documents, assurances, applications and other instruments as may reasonably be required by said Assignee, its successors, assigns or legal representative, to obtain from Assignor the rights granted hereunder in any and all US Trademarks, and to execute such further lawful assignments, documents, assurances, applications and other instruments as may reasonably be required by said Assignee, its successors, assigns or legal representative to establish use of said any and all US Trademarks.
